# **REPUBLIC OF SRPSKA IN OPEN DAYS 2012**



# 10<sup>th</sup> European Week of Regions and Cities Brussels 8 - 11 October 2012

Together with the regions from Italy, Slovenia, Croatia and Serbia the Regional Representation of Republic of Srpska set up a partnership on Adriatic Ionian macro region. A workshop and debate organized by the conglomerate in Brussels addressed a new framework for cross-border cooperation. A partner in the conglomerate from the Re-



public of Srpska was Agency for Development of Small and Medium Sized Enterprises. Common challenges and opportunities linked to EU Enlargement as well as successful cooperation and projects implemented by the partner regions were prevailing as a motive of the discussions by different participants from the regions and the EU institutions.

# REPUBLIC OF SRPSKA REPRESENTATION HOLDS RECEPTION FOR 17TH ANNIVERSARY OF DAYTON

Held in the Press Club Europe in Brussels this was an excellent opportunity to remind people of the Dayton Peace Accord's significance in stopping the war and establishing the current political system in Bosnia and Herzegovina and as the most fundamental foundation for any reform or constitutional change, said in his announcement Mr. Mario Djuragic, Director of the Representation in Brussels. A guest of honor, Mrs. Zeljka Cvijanovic, the Minister for Economic relations and Regional Cooperation in the Government of the Republika Srpska addressed the audience and appealed that the peace had no alternative and it was the time the OHR leaves and give Bosnia and Herzegovina a chance to finally step out towards real sovereignty and responsibility for its own destiny.

The government of Republic of Srpska has launched a new website highlighting opportunities for foreign investors interested in doing business in RS. The site, <u>www.investsrpska.net</u>, serves as a portal for all investment-related information. Encouraging foreign direct investments is one of the RS government's key development strategies; the government has already entered into several joint ventures with foreign firms in the energy and infrastructure sectors, and seeks to increase foreign investment over the next four years. The main contact point for investors is the Ministry of Economic Relations and Regional Cooperation, led by Minister Željka Cvijanović. The Ministry's Economic Cooperation Sector stands ready to provide all necessary information to foreign investors concerning investment opportunities, legal regulations, institutions available to investors, as well as any other necessary information.

# REPUBLIC OF SRPSKA TOOK OVER THE PRESIDENCY OF SEPCA



Serbian Republic took over the presidency today, the Southeast Europe Police Chiefs Association (SEPCA), and the first meeting of the newly elected Executive Committee chaired by the director of the Republic of Srpska po-

lice Mr. Gojko Vasic, was held in Banja Luka.

The idea of the functioning of the Southeast Europe Police Chiefs Association is that cooperation at the level of director proves that freedom to all subordinates to cooperate, without limitation, and no particular formality as it was in the past.

# RWE SIGNED EUR 460M DEAL TO BUILD HYDRO POWER PLANTS

Joint venture project of 4 hydro power plants "Gornja Drina" was signed between representatives of the German company RWE from Essen and Power Utility of the Republic of Srpska. The project includes four hydro power plants "Buk Bijela", "Foca", "Paunci" and "Sutjeska". Director General of "Power Utility of the Republic of Srpska", Ms. Branislava Milekic said that the installed capacity of the four plants will be 260 MWh and annual electricity production up to 760 GWh.

### ITALY'S METALLEGHE INVESTS EUR 30M IN METAL PROCESSING FACILITY

An Italian firm plans to expand its investment in a metal processing facility in Mrkonjic Grad, Republic of Srpska. Metalleghe has been operating in the Republic of Srpska since 2004. The new investment will comprise the construction of a furnace and supporting facilities that will increase overall production at its Mrkonjic Grad facility, which exports metals to several European states.

# REPUBLIC OF SRPSKA SIGNS UP FOR SOUTH STREAM PIPELINE



The President of Republic of Srpska, Mr. Milorad Dodik, has signed an agreement with the Russian company Gazprom to build a part of the South Stream pipeline network. Dodik said the contract also entails building gas power plants, with potentially enough generating capacity to make Republika Srpska one of the most important power producers in the region. Gazprom and the government of Republika Srpska will form a joint company in the next year, after which the exact path of pipelines will be determined and construction work will begin.
